Graduate Profile and Rationale

The Graduate Certificate in Arts course is designed for those who hold a tertiary qualification in a non-theological discipline, who wish to pursue a graduate qualification in theology, and who are seeking skills in theological studies to enhance their professional work.

Outcomes

On completion a student should be able to:

- display a foundational understanding of central issues in the sub-disciplines of Biblical Studies and Theology
- be familiar with the basic primary and secondary literature of the specified

theological discipline

- display an initial appreciation of the contribution of theological disciplines to understanding life experience and Church issues
- be able to respond in a theological manner to life experiences and Church issues

Enrolment

The GradCertArts is offered through individual Member Institutions. In light of the units offered students are able to choose their program to suit their interests and needs, all the while fulfilling the requirements. Details are available from the Member Institution offering the course.

Assessment

Graduate students are expected to give evidence of a breadth of research and a depth of understanding beyond that of an undergraduate student. In particular, their work should manifest the higher order skills of:

- Analysis - the ability to break down what is presented into its component parts and indicate the relationship between those parts;
- Synthesis - the ability to re-assemble those component parts into a new whole;
- Evaluation - the ability to think critically and originally, making judgments based on relevant principles.

Articulation to Other Awards

Students are eligible to articulate to the Graduate Diploma of Arts or the Master of Arts, on completion of which students are required to surrender their Graduate Certificate.

ACADEMIC REGULATIONS for the GradCertArts

1. *Admission to Candidature*

- 1.1 An applicant for admission to candidature for a degree of Graduate Certificate in Arts shall:
 - a) have qualified for admission to a three-year degree from an accredited Australian tertiary institution; or
 - b) hold, from a university or other tertiary institution, qualifications approved by the Student Administration Committee as equivalent to a three year degree;
- 1.2 Notwithstanding the provisions of this regulation the Student Administration Committee may require an applicant to demonstrate fitness for admission as a candidate for this degree by carrying out such work and/or sitting for such examinations as the Student Administration Committee may determine.
- 1.3 In exceptional cases an applicant may be admitted as a candidate for a Graduate Certificate in Arts if the applicant submits evidence of other academic and professional attainments to the Student Administration Committee.

- 1.4 A Candidate for the award shall be designated as full-time or part-time. A student is designated as a full-time if enrolled in three units (27 credit points) or more in a semester or part-time if enrolled in less than three units (27 credit points) per semester.
- 1.5 No candidate for the award may be concurrently enrolled in any other undergraduate or postgraduate course within the Sydney College of Divinity or any other tertiary institution, unless approval has been granted by the Academic Board.
- 1.6 Applicants whose entry qualifications were obtained in an institution where English is not the language of instruction normally will be required to demonstrate competency in English by an IELTS (or equivalent) result of 7.0 in all bands of the test and may be required to attend such English language courses as prescribed by the Sydney College of Divinity.
- 1.7 Application for enrolment in the Graduate Certificate in Arts program is made to the Registrar of the appropriate Member Institution offering the program.

2 Course Structure

- 2.1 The Graduate Certificate in Arts requires the completion of 4 units (36 credit points).
- 2.2 All course units shall be taken from the Schedule of Units of Study at 400 and 500 level.

3 Period of Candidature:

- 3.1 The period of candidature for the degree shall normally be six months full time and 18 months part-time.
- 3.2 In certain circumstances the Student Administration Committee may grant extensions to the period of candidature.

4 Leave of Absence

- 4.1 The Student Administration Committee may grant leave of absence from the Graduate Certificate in Arts. The period of leave shall not be counted as part of the period of candidature for the degree.
- 4.2 The period of leave shall normally be one semester after which a candidate may apply for a further period of one semester or is required to complete candidature.

5 Assessment

- 5.1 The assessment of subject units shall be in the manner approved by the Academic Board in line with the College's established guidelines for assessment packages for units at 400 and 500 level.
- 5.2 Students may be required by the Academic Board to present themselves for oral examination.
- 5.3 Academic and non-academic misconduct will be penalised severely in accordance with the regulations of the Sydney College of Divinity.

6 Credit

- 6.1 A candidate may seek credit up to a maximum of 18 credit points in the Graduate Certificate in Arts. Credit can be granted only from units at graduate level where the outcomes, content, demand hours and assessment are equivalent to that of units in the SCD award.

7 Saving Clause

The Graduate Diploma of Arts course is designed for those who hold a tertiary qualification in a non-theological discipline, who wish to pursue a graduate qualification in theology, and who are seeking skills in theological studies to enhance their professional work.

- develop critical skills in dealing with the primary and secondary literature of the specified theological discipline
- display a developed appreciation of the contribution of the specified theological discipline to an understanding of life experience and Church issues
- to respond critically in light of the specified theological discipline to life experiences and Church issues

Enrolment

The GradDipArts is offered through the Member Institutions. In light of the units offered students are able to choose their program to suit their interests and needs, all the while fulfilling the requirements. Details are available from the Member Institution offering the course.

Assessment

Graduate students are expected to give evidence of a breadth of research and a depth of understanding beyond that of an undergraduate student. In particular, their work should manifest the higher order skills of:

- Analysis - the ability to break down what is presented into its component parts and indicate the relationship between those parts;
- Synthesis - the ability to re-assemble those component parts into a new whole;
- Evaluation - the ability to think critically and originally, making judgments based on relevant principles.

Exit points

Students enrolled in the GradDipArts may exit with the Graduate Certificate in Arts provided they have met the requirements of the award.

Articulation to Other Awards

Students are eligible to articulate to the Master of Arts offered by the Sydney College of Divinity, on completion of which students are required to surrender their GradDipArts.

ACADEMIC REGULATIONS for the GradDipArts

1. *Admission to Candidature*

1.1 An applicant for admission to candidature for a degree of Graduate Diploma of Arts shall:

- a) have qualified for admission to a three-year degree from an accredited Australian tertiary institution; or
- b) hold, from a university or other tertiary institution, qualifications approved by the Student Administration Committee as equivalent to an accredited three-year degree;
- c) hold an SCD Graduate Certificate in Arts: to receive the award a student is required to complete a further 36 credit points (four units), and hand back the GradCertArts upon graduation.

1.2 Notwithstanding the provisions of this regulation the Student Administration Committee may require an applicant to demonstrate fitness for admission as a candidate for this degree by carrying out such work and/or sitting for such examinations as the Student Administration Committee may determine.

1.3 In exceptional cases an applicant may be admitted as a candidate for a Graduate Diploma of Arts if the applicant submits evidence of other academic and professional attainments to the Student Administration Committee.

1.4 A candidate for a Graduate Diploma of Arts shall be designated as full-time or part-time. A student is designated as a full-time if enrolled in three units (27 credit points) or more in a semester or part-time if enrolled in less than three units (27 credit points) per semester.

1.5 No candidate for the award may be concurrently enrolled in any other undergraduate or postgraduate course within the Sydney College of Divinity or any other tertiary institution, unless approval has been granted by the Academic Board.

2.3 The course may be taken with or without a specialisation. A specialisation in the GradDipArts comprises 36 credit points in a sub-discipline with at least one unit at 500 level.

2.4 Students who enter the program from a BTh or equivalent cannot do units with content similar to those covered in their undergraduate studies.

3 *Period of Candidature:*

- 3.2 In certain circumstances the Student Administration Committee may grant extensions to the period of candidature.

4 *Leave of Absence*

- 4.1 The Student Administration Committee may grant leave of absence from the Graduate Diploma of Arts. The period of leave shall not be counted as part of the period of candidature for the degree.
- 4.2 The period of leave shall normally be one semester after which a candidate may apply for a further period of one semester or is required to complete candidature.

5. *Assessment*

- 5.1 The assessment of subject units shall be in the manner approved by the Academic Board in line with the College's established guidelines for assessment packages for units at 400 and 500 level.

Enrolment

The Master of Arts course is offered through the individual Member Institutions. In light of the units offered students are able to choose their program to suit their interests and needs. Different Member Institutions have developed programs of study within the MA that enable a student to specialise in a particular area, such as biblical studies, urban ministry or liturgy. These programs may have specific entry conditions and required units. Details are available from the Member Institution offering the specialisation.

Assessment

Masters students are expected to give evidence of a breadth of research and a depth of understanding beyond that of an undergraduate student. In particular, their work should manifest the higher order skills of:

- Analysis - the ability to break down what is presented into its component parts and indicate the relationship between those parts;
- Synthesis - the ability to re-assemble those component parts into a new whole;
- Evaluation - the ability to think critically and originally, making judgments based on relevant principles.

Exit points

Students enrolled in the MA may exit with the Graduate Certificate in Arts (36 cr pts) or the Graduate Diploma of Arts (72 cr pts), provided they have met the requirements of those awards.

Articulation to Other Awards

Students are eligible to articulate to the MA(Hons) provided they have achieved the MA with a grade point average of 2.8 or better and including the Research Essay at distinction level. The MA is itself an exit point within the Master of Divinity program.

An MA (SCD) with a particular specialisation can be considered an entry point into the MTh on the following conditions:

- a. The specialization in the MTh must be the same as the specialization undertaken in the MA;
- b. In order to undertake coursework units listed on the schedule of course units for the Master of Theology, the student must have met the pre-requisites for those coursework units.

ACADEMIC REGULATIONS for the MA

1. *Admission to Candidature*

- 1.1 An applicant for admission to candidature for a degree of Master of Arts must:
 - a) have qualified for admission to a three-year degree from an accredited Australian tertiary institution; or
 - b) hold, from a university or other tertiary institution, qualifications approved by the Student Administration Committee as equivalent to an accredited three-year degree;
 - c) hold an SCD Graduate Certificate in Arts: to receive the award the student is required to complete a further 72 credit points (eight units), and hand back the GradCertArts upon graduation
 - d) hold an SCD Graduate Diploma of Arts: to receive the award the student is required to complete a further 36 credit points (four units), and hand back the GradDipArts upon graduation.
 - e) hold a Vocational Graduate Diploma (VET accredited).
 - f) hold a Vocational Graduate Certificate (VET accredited) and be granted provisional admission.
 - g) Professional entry may be granted subject to criteria set out in the SCD Admissions Policy
- 1.2 Notwithstanding the provisions of this regulation the Student Administration Committee may require an applicant to demonstrate fitness for admission as a candidate for a degree of Master by carrying out such work and/or sitting for such examinations as the Student Administration Committee may determine.
- 1.3 In exceptional cases an applicant may be admitted as a candidate for a degree of Master if the applicant submits evidence of other academic and professional attainments to the Student Administration Committee.
- 1.4 A Candidate for the award shall be designated as full-time or part-time. A student is designated as a full-time if enrolled in three units (27 credit points) or more in a semester or part-time if enrolled in less than three units (27 credit points) per semester.
- 1.5 No candidate for the award may be concurrently enrolled in any other undergraduate or postgraduate course within the Sydney College of Divinity or any other tertiary institution, unless approval has been granted by the Academic Board.

1.7 Application for enrolment in the Master of Arts program is made to the Registrar of the appropriate Member Institution offering the program.

2 Course Structure

2.1 The candidate undertaking the Master of Arts is undertaking the culmination of three nested awards in which;

- a) the Graduate Certificate in Arts requires the completion of 4 units (36 credit points);
- b) the Graduate Diploma of Arts requires the completion of 8 units (72 credit points);
- c) the Master of Arts requires the completion of 12 units (108 credit points);
- d) a maximum of 36 credit points in research units, with no more than 18 credit points in Independent Guided Study units, 18 credit points in Research Project units and 18 credit points as a Research Essay (students who transfer from the MA to either the MDiv or the MTh cannot exceed this limit in total across both programs);
- e) 18 credit points may be taken in the Research Essay of 10,000-12,000 words in length and written in the area of specialisation under supervision of a staff member of the Member Institution. Each student enrolled in the Research Essay must complete a 600 level Research Methodology Unit (9 cr pts) that is completed before or concurrently with the Research Essay.
- f) if admission or provisional admission has been granted on the basis of a Vocational Graduate Diploma or Graduate Certificate, the unit AL420 *Critical Thinking and Writing* is required (core) in the student's program.

2.2 All course units shall normally be taken from the Schedule of Units of Study at 400 and 500 level. Course units at 600 level may be undertaken provided that at least four foundational course units in the sub-discipline have been completed, and 54 credit points in the award been completed.

2.3 The course may be taken with or without a specialisation. A specialisation in the MA comprises 54 credit points in a sub-discipline with at least two units at 500 level or above.

2.4 Students who enter the program from a BTh or equivalent cannot do units with content similar to those covered in their undergraduate studies.

2.5 Candidates wishing to proceed to the Master of Arts (Honours) must include the Research Essay as part of the program, and are required to achieve a Distinction grade.

3 Period of Candidature

3.1 The period of candidature for the degree shall normally be one and a half years full time and four and a half years part-time.

3.2 In certain circumstances the Student Administration Committee may grant extensions to the period of candidature.

4 Leave of Absence

4.1 The Student Administration Committee may grant leave of absence from the award. The period of leave shall not be counted as part of the period of candidature for the degree.

The Master of Divinity is offered through the individual Member Institutions.

Assessment

Graduate students are expected to give evidence of a breadth of research and a depth of understanding beyond that of an undergraduate student. In particular, their work should manifest the higher order skills of:

- Analysis - the ability to break down what is presented into its component parts and indicate the relationship between those parts;
- Synthesis - the ability to re-assemble those component parts into a new whole;
- Evaluation - the ability to think critically and originally, making judgments based on relevant principles.

Exit points

Students enrolled in the MDiv may exit with the Graduate Certificate in Arts (36 cr pts) or the Graduate Diploma of Arts (72 cr pts) or the Master of Arts (108 cr pts), provided they have met the requirements of those awards.

Articulation to Other Awards

Students may articulate to the Master of Theology (Honours), the Master of Arts (Honours) and the Doctor of Ministry programs provided they meet the entry requirements.

ACADEMIC REGULATIONS for the MDiv

1. *Admission to Candidature*

1.1 An applicant for admission to candidature for a degree of Master of Divinity shall:

- a) have qualified for admission to a three-year degree from an accredited Australian tertiary institution; or
 - b) hold, from a university or other tertiary institution, qualifications approved by the Student Administration Committee as equivalent to the requirements set out in the paragraph above; or
 - c) hold an SCD Graduate Certificate in Arts: to receive the award the student is required to complete a further 180 credit points (20 units), and hand back the GradCertArts upon graduation; or
 - d) hold an SCD Graduate Diploma of Arts: to receive the award the student is required to complete a further 144 credit points (16 units), and hand back the GradDipArts upon graduation; or
 - e) hold an SCD Master of Arts: to receive the award the student is required to complete a further 108 credit points (12 units), and hand back the MA upon graduation.
- 1.2 Notwithstanding the provisions of this regulation the Student Administration Committee may require an applicant to demonstrate fitness for admission as a candidate for a degree of Master of Divinity by carrying out such work and/or sitting for such examinations as the Student Administration Committee may determine.
- 1.3 In exceptional cases an applicant may be admitted as a candidate for a degree of Master of Divinity if the applicant submits evidence of other academic and professional attainments to the Student Administration Committee.
- 1.4 A candidate for the award shall be designated as full-time or part-time. A student is normally designated as a full-time if enrolled in three units (27 credit points) or more in a semester or part-time if enrolled in less than three units (27 credit points) per semester.
- 1.5 No candidate for the award may be concurrently enrolled in any other undergraduate or postgraduate course within the Sydney College of Divinity or any other tertiary institution, unless approval has been granted by the Academic Board.
- 1.6 Applicants whose entry qualifications were obtained in an institution where English is not the language of instruction normally will be required to demonstrate competency in English by an IELTS (or equivalent) result of 7.0 in all bands of the test and may be required to attend such English language courses as prescribed by the Sydney College of Divinity.
- 1.7 Application for enrolment in the Master of Divinity program is made to the Registrar of the appropriate Member Institution offering the program.

2 Course Structure

- 2.1 Every student program for the award shall consist of no fewer than 216 credit points.
- 2.2 Every program shall include either two majors and one sub-major or one major and two sub-majors. A major requires 54 credit points from units assigned to the major including no more than 18 credit points at foundational level or with the approval of the Academic Board, up to 54 credit points at advanced level. A sub-major requires 36 credit points from the units assigned to the major, including no more than 18 at foundational level or, with the approval of the Academic Board, up to 36 credit points at advanced level.
- 2.3 Every program for the award shall include:

- a. not more than 90 credit points taken at 400 level;
 - b. not more than 72 credit points from Philosophy and Humanities;
 - c. at least a sub-major from Biblical Studies;
 - d. students completing a major in Biblical Studies must also complete at least 2 units in Biblical languages which are in addition to the 6 units required for a major;
 - e. at least a sub-major from Theology;
 - f. at least one unit in Church History;
 - g. at least 36 credit points from the following sub-disciplines: Theological Ethics, Christian Spirituality, Liturgical Studies, Missiology, Pastoral Theology and Practice;
 - h. not more than 108 credit points in Pastoral Theology and Practice
 - i. 6 units, which may include a Research Essay, at 600 and 700 level, which may be undertaken on completion of 12 units (108 credit points) of the total program including 36 credit points in the sub-discipline.
 - j. a maximum of 36 credit points in research units, with no more than 18 credit points in Independent Guided Study units, 18 credit points in Research Project units and 18 credit points as a Research Essay (students who transfer from the MA to either the MDiv or the MTh cannot exceed this limit in total across both programs);
 - k. 18 credit points may be taken in the Research Essay of 10,000-12,000 words in length and written in the area of specialisation under supervision of a staff member of the Member Institution. Each student enrolled in the Research Essay must complete a 600 level Research Methodology Unit (9 cr pts) that is completed before or concurrently with the Research Essay.
- 2.4 Candidates may apply to the Academic Board of their Member Institutions to include in the major or sub-major sequence units from other areas of study.
- 2.5 All course units shall be taken from the Schedule of Units of Study for units at 400, 500, 600 and 700 level.
- 3 *Period of Candidature***
- 3.1 The period of candidature for the degree shall normally be 3 years full-time and 9 years part-time.
- 3.2 In certain circumstances the Student Administration Committee may grant extensions to the period of candidature.
- 4 *Leave of Absence***
- 4.1 The Student Administration Committee may grant leave of absence from the MDiv. The period of leave shall not be counted as part of the period of candidature for the degree.
- 4.2 The period of leave shall normally be one semester after which a candidate may apply for a further period of one semester or is required to continue candidature.
- 5. *Assessment***
- 5.1 The assessment of subject units shall be in the manner approved by the Academic Board in line with the College's established guidelines for assessment packages at 400 and 500 as well as at 600 and 700 level.
- 5.2 Students may be required by the Academic Board to present themselves for oral examination.

5.3 Academic and non-academic misconduct will be penalised severely in accordance with the regulations of the Sydney College of Divinity.

6. *Credits*

6.1 A candidate may seek credit up to a maximum of 108 credit points in the Master of Divinity. Credit can be granted only from units at graduate level where the outcomes, content, demand hours and assessment are equivalent to that of units in the SCD award.

7.1 Notwithstanding anything to the contrary contained herein, the Academic Board of the Sydney College of Divinity may, in any case in which it may deem it appropriate to do so, vary, dispense with or suspend any requirement or prescription by these regulations, and report forthwith to the Council of the Sydney College of Divinity.

ACADEMIC REGULATIONS for the MTh

1 Admission to Candidature

 - b) have qualified for admission to the Master of Arts of the Sydney College of Divinity and take up the same specialisation in the MTh which was undertaken in the MA program and meet the pre-requisites for any coursework units in the MTh, or
 - c) shall hold, from a university or other tertiary institution, qualifications approved by the Student Administration Committee as equivalent to an accredited Bachelor of Theology degree.
- 1.2 Notwithstanding the provisions of this regulation the Student Administration Committee may require an applicant to demonstrate fitness for admission as a candidate for a degree of Master of Theology by carrying out such work and/or sitting for such examinations as the Student Administration Committee may determine.
- 1.3 In exceptional cases an applicant may be admitted as a candidate for a degree of Master of Theology if the applicant submits evidence of other academic and professional attainments to the Student Administration Committee.
